

## **BOARD MINUTES: AUGUST 6, 2024**

The A.A.C.A. South Florida Region Board Meeting of Tuesday, August 6, 2024, was called to Order by President Tomás Hernández at 7:30 p.m., at Rinconcito Latino Café, 9606 SW 72<sup>nd</sup> Street, Miami, FL 33173.

In Attendance: President Tomás Hernández, 1<sup>st</sup> Vice-President Al Padilla, 2nd Vice-President Jorge Feria, Secretary Yovanna Hernández, Immediate Past President Millie Garcia, and Board Members Jean Hawa, Thomas Kosky, Ed Medina, Mike Penn, Paula Valentina Perez, Jorge Salazar, Ira Shapiro, and Bob Squier.

**Establish a Quorum:** President Tomás Hernández was able to establish a quorum with 13 members of the board present.

First Order of Business - Acceptance of Board Meeting Minutes from Previous Month: President Tomás Hernández asked if everyone present had read the minutes of the July board meeting; if so, and if there were no questions, comments, or corrections, would someone move to accept the minutes as posted. Ira Shapiro made a motion to accept the minutes, Bob Squier seconded it. Having no other discussion, the motion was voted on and passed.

#### **Second Order of Business – Treasurer's Report:**

Immediate Past President Millie Garcia, on behalf of Manny Garcia, presented a reconciliation statement for July from the club's bank account.

**Third Order of Business – Membership Report:** Ed Medina reported that as of now we have 204 active families.

General Membership Meeting (August 15, 2024): President Tomás Hernández mentioned that since Memory Lane was so close that we should not have a guest speaker this month. Instead, we will dedicate this meeting to go over details and concerns of Memory Lane and requesting that all car owners with an entry should attend this meeting.

Memory Lane (August 30<sup>th</sup> – September 8<sup>th</sup>): Ed Medina mentioned that everything is going fine and insurance for the show has been pulled. He also said:

- There are 53 cars registered at this moment.
- Every member exhibiting a car will receive a credential and two complimentary tickets to enter the show.

- their car information to him.
- The plan is to display the cars chronologically along the east-west wall.

**Establish a Quorum:** President Tomás Hernández was able to establish a quorum with 15 members of the board present.

First Order of Business - Acceptance of Board Meeting Minutes from Previous Month: President Tomás Hernández asked if everyone present had read the minutes of the August board meeting; if so, and if there were no questions, comments, or corrections, would someone move to accept the minutes as posted. # ARTICLE FOUR – ELECTION OF OFFICERS AND BOARD OF DIRECTORS

SECTION I: The Board of Directors shall consist of no

more than nineteen (19) members to include a maximum of fourteen (14) Directors to include the immediate Past President and Club Counsel (if applicable) and five (5) Officers of the Region elected by the membership. The officers of the Region shall be a Regional President, First Regional Vice President, Second Regional Vice President, Secretary and Treasurer. To be eligible to be elected to the Board of Directors he or she shall be a member in good standing for two (2) consecutive years with proven contributions to the operation of the club

SECTION II: The Nominating Committee shall be

activities.

comprised of five (5) members. The Regional President shall select the chairperson of the Nominating Committee. The remaining four (4) members shall be selected at the September general membership meeting

by the membership.

SECTION III: The nominating committee shall present a recommendation of candidates for Officers

and the Board of Directors at the October general membership meeting. The floor will be open for nominations from the floor at the October general membership meeting and closed prior to the election at the November general membership meeting. The Nominating Committee's slate and the candidates' names nominated, during the October meeting, will be published in the November issue of

Sidelights.

SECTION IV: Members in good standing with the Region

will be given proper notice of the election by means of Sidelights or Region's website. The election for officers and the Board of Directors shall take place at the November general membership meeting and members must be present to vote; there shall be no proxies or absentee ballots allowed. There shall be a secret written ballot, which will be collected and tallied by the Regional Secretary or designee.

SECTION V: All officers and members of the Board of

Directors may succeed themselves with the exception of the President who may serve a maximum of two consecutive

years.

SECTION VI: In the event of a resignation of an officer or

Board member or vacancy on the Board of Directors, the President may choose to appoint a replacement to fill the vacancy

until the next election.

#### ARTICLE FIVE - TERMS OF OFFICE

SECTION I: The elected

The elected officers of this Region shall be a Regional President, First Regional Vice President, Second Regional Vice President, Secretary and Treasurer. Officers are elected for terms of one year. The Office of President is restricted to a maximum of two consecutive years. The Board of Directors will consist of up to fourteen (14) members including the Immediate Past President and Club Counsel (if applicable). The Board of Directors shall be elected for a term of two years on a staggered basis – one-half of the Board shall be elected each vear. The Officers and Directors shall be sworn into their office at the annual yearend holiday party, typically held in

December.

## RICH'S REPAIR RAMBLINGS


An internal combustion automobile engine creates a tremendous amount of heat which will cause extensive engine damage unless there is some sort of mechanism to carry that heat away. While some engines are aircooled, using a combination of fans, shrouding, and finned engine externals (greater surface area) to force ambient air around an engine's exterior, most automotive engines are liquid-cooled. Such engines employ a cooling system, circulating a liquid through the engine's internal passages, which transfers the heat from the engine to the cooling medium. (The 2nd Law of Thermodynamics states that heat moves from higher temperature bodies to lower temperature bodies.) The hot liquid is then pumped to a heat exchanger (radiator), where the heat is released to the atmosphere. The nowcooler liquid is circulated back into the engine and the cycle begins anew.

Plain old water (H2O) is actually a very efficient medium for engine cooling. Its two main drawbacks are its propensity to cause corrosion when interacting with certain metals, and the temperature limits within which it

will remain in a liquid state (water freezes at 32 degrees F/zero degrees C and boils at 212 degrees F/100 degrees C). Once it's no longer a liquid, it cannot perform its job to carry away engine heat.

Most of us know that our "water-cooled" engines actually use some percentage of a substance called antifreeze, diluted with water. Automotive reference books have little to say about the early history of antifreeze. While it is noted that water alone was initially used as a coolant, it was also recognized that anyone living where temperatures fell below freezing would risk engine damage if the cooling system wasn't drained first. (Liquid water, if allowed to freeze, will expand slightly. Difficult to believe, but true, is the fact that water which is allowed to freeze inside an engine block can cause the block to crack.)

There is some consensus that a French chemist, Charles Adolphe Wurtz, was the first to formulate the substance he named ethylene glycol in 1859. Among its early uses was in the manufacture of explosives. A U.S. plant to manufacture ethylene glycol was opened in 1925 by the company which became Union Carbide, and 1926 saw its first use in automotive cooling systems when it was discovered that its freezing point was below that of plain water.

Interestingly, two additional properties of ethylene glycol were discovered: one, its freezing point could be brought even lower when mixed with water; and two, when used in a pressurized closed cooling system, its boiling point was raised to that above plain water. One downside of the stuff is that it has a "sweet" taste to creatures who wouldn't know better than to ingest it (children and animals) and it is extremely toxic when swallowed. To its credit, the antifreeze industry has added bittering agents to ethylene glycol to help prevent inadvertent consumption.

My copy of the 6th Edition of the *Bosch Automotive Handbook* (published in 2004) contains a chart of freezing and boiling points of water-glycol mixture ratios. At 10% glycol (90% water), the freezing point drops to 25 F and the boiling point to 214 F. A 30% mix improves that to a freezing point of 1 degree F and a boiling point of 220 F. Finally, a 50/50 mixture won't freeze until the temperature drops to 38 F, and won't boil until it climbs to 226 F. Clearly, the 50/50 solution suffices for almost all driving situations in the U.S.

Over time, chemical engineers added corrosion inhibitors to antifreeze to minimize any corrosive effects on the materials of both the engine and the radiator, including cast iron, aluminum, copper, and brass. As engines and their related systems became more and more complex, engineers from various auto manufacturers also started specifying antifreezes formulated in new and improved ways (and color-keyed to distinguish them from one another). Similar to most fluids used in vehicular applications, antifreeze has a lifespan beyond which its protective qualities have deteriorated. When that happens, it's time for a drain/flush/refill. The type of antifreeze needed for your jalopy, along with the correct percentage of water to add, should be matters of attention when performing this service.

# BEST OF SHOW 1973 CITROEN DS HENRI CHAPRON SERIES II Owned by Volker Ribniger

# BRIEF MANUFACTURER DETAILS AND SIGNIFICANT HISTORY OF CAR:

The Citroën DS is a front-engine, front-wheel-drive mid-size car manufactured and marketed by the French company Citroën from 1955 to 1975 in sedan, wagon/estate and convertible body configurations. Italian sculptor and industrial designer Flaminio Bertoni and the French aeronautical engineer André Lefèbvre styled and engineered the car. Paul Magès developed the hydro pneumatic self-levelling suspension.

Noted for its aerodynamic, futuristic body design and innovative technology, the DS set new standards in ride quality, handling, and braking. Citroën sold 1,455,746 cars, including 1,330,755 built at the manufacturer's original mass-production plant in Paris at the Quai André-Citroën (previously the Quai de Javel).

The DS came third in the 1999 Car of the Century poll recognizing the world's most influential auto designs and was named the most beautiful car of all time by *Classic & Sports Car* magazine.

















# OLDEST VEHICLE: 1896 Ford Quadricycle Owned by Rick Eggers

#### **BRIEF MANUFACTURER DETAILS & SIGNIFICANT HISTORY OF CAR:**

**Henry** Ford's first attempt at building a gas-powered vehicle.


He found a design for a two-cylinder horizontal engine that he loosely copied, and built a simple bicycle-tired car with which to experiment on the engine. Only one example was built, as he moved on to bigger and better vehicles. The original Quadricycle currently resides at the Henry Ford Museum in Dearborn, Michigan.

#### **BRIEF STORY OF THIS PARTICULAR VEHICLE:**

In the early 60's, an engineer named George DeAngelis working for Ford, decided he wanted to build a replica of Henry's Quadricycle. Ford gave him permission to disassemble much of it and make blueprints and drawings of all the details. He built three examples, and afterward made his drawings available for purchase by enthusiasts wanting their own Quadricycle. I built this car from his drawings, and also as many close-up pictures of the original car as I could find. Those two things together make this car one of the most exact copies of the Quadricycle around.









#### IN MEMORIAM



# "America's Automotive Library" Identifies its Oldest Artifacts By Steve Rossi VP -Public Relations & Event Planning

The Chris & Kathleen Koch AACA Library & Research Center has identified its oldest antique automotive artifact. The collection includes *A Handbook for Steam Users Being Rules for Engine Drivers and Boiler Attendants* by M. Powis Bale, from 1890. In addition, a February 14, 1891, issue of *Scientific American* features an analysis of the 3 wheeled Butler Petrol-Cycle from Great Britain.

According to Library Director Jen Wolfe, "Since automotive history is an inexact science, trying to pinpoint the first piece of automotive material ever published is impossible...though Duryea is credited with producing the first American automobile in series by 1896." Some believe that Panhard began producing promotional literature...in color...during 1892 (from Panhard & Levassor: *Pioneers in Automobile Excellence*, by David Beare). Which the AACA artifacts predate.

The Smithsonian's Smith Hempstone Oliver contended that the first automotive catalog appeared in 1888/1889, from Philadelphia's Moto-Cycle Manufacturing Company which featured Lucius D. Copeland-designed steam cycles and steam carriages. Along with typewriters (*The Bulb Horn*, May-June 1966). Either way, as a function of the publication timeline above, "America's Automotive Library" is at the forefront.

The AACA Library & Research Center was established in 1977 and houses some 3+ million individual automotive artifacts at its Hershey, PA headquarters, and is the largest and most comprehensive institution of its kind. In addition, the Library also oversees nine single -marque collections within its climate controlled, secure and professionally managed facility which includes a state of the art fire suppression system.

The Library is free and open to the public. Research requests are included with AACA membership (for the first two hours at no charge, per year), while additional photo copies, scans and reproductions are further available for a fee. Donations such as literature, books, artwork, manuals, periodicals, toys/models, etc. are welcomed and encouraged. Upon receipt of materials, the Library will provide the donor with a letter acknowledging the gift. See www.aacalibrary.org for more information.
